

# Unstoppable Sweepstakes

## Terms and Conditions:

- 1. Sweepstakes Period:** The Unstoppable Sweepstakes (the “Sweepstakes”) commences at 12:00 a.m. CST January 1, **2025** and closes at 11:59 p.m. CST December 31, 2025 (the “Sweepstakes Period”).
- 2. Eligibility:** The Unstoppable Sweepstakes is open to residents of the 50 United States of America or the District of Columbia, who are 18 years of age or older at the time of entry. Void outside of the United States, in Puerto Rico, and wherever else is prohibited by law.
